

**Secondary Graduate Licensure Program - Vocal**  
**Department of Curriculum and Instruction/Department of Music**  
**University of Nevada, Las Vegas**

**Program**

The purpose of the program is to attract individuals with a bachelor's degree who are interested in a track designed to provide training for achieving teacher licensure for secondary level teaching in vocal music education and a master's degree. This program is designed to support highly qualified students in their preparation.

**Prerequisite Admissions Requirements**

- Bachelor's degree with overall GPA of 2.75 or above in the Comprehensive Subject (Vocal) Area.
- Content coursework related to general music core for music majors. Students should have ensembles that mirror the appropriate undergraduate degree program.
- Passing scores in reading, writing, and mathematics on the Praxis I Pre-Professional Skills Test (PPST) examination: R (174) W(12) M (172)
- Passing scores on the Music Theory and Music History entrance examinations.
- Passing scores on the Teacher Licensure Examinations for Nevada School Law, Nevada Constitution and U.S. Constitution or related coursework

  - Courses: EDA 200 Nevada School Law (2 credits); HIS 100 Historical Issues and Contemporary Man or POS 100 Introduction to American Politics (4 credits for both US and Nevada Constitution); POS 101 Nevada Constitution (1 credit)
- Documentation of immunizations with UNLV Admissions and Records

- Fingerprinting in compliance with the Clark County School District (CCSD) policy

**Application Process for UNLV Admissions**

- Audition as required by the Department of Music for master students.
- Submit official application with appropriate fees and official transcripts to UNLV Admissions and Records, ATTN: Flora Jones, Special Programs Officer.
- Submit documentation of immunization records. Applicants who earn a bachelor's degree at UNLV and have immunization records on file are exempt.
- Application will be processed and forwarded to the C&I Professional Development Office.

**Application Process for Curriculum and Instruction (C&I)**

- Submit copies of passing PPST reading, writing, and mathematics scores to C&I Professional Development Office, CEB 367A
- Submit copies of passing scores on the Teacher Licensure Examination(s) or transcript verification of related coursework to C& I Professional Development Office, CEB 367A
- Submit 1-2 page statement of professional goals, with two professional references, to the C&I Professional Development Office, CEB 367A.
- Application will be processed and reviewed by the C&I Professional Development-Initial Licensure Program coordinator and the Department of Music - Music Education Coordinator.

**Program Requirements**

Applicant must complete a one-year program of study and one semester of supervised student teaching. Should the applicant wish to extend the program beyond one-year, contact the Professional Development Office, CEB 367A, 895-1536, or [cipdilp@unlv.nevada.edu](mailto:cipdilp@unlv.nevada.edu) for options in revising the course schedule.

Upon completion of all requirements, students have completed the requirements for a Master of Education degree and will be eligible to apply for **7-12 music education teacher licensure** in Nevada. \*\* Students are responsible for knowing and meeting all licensure requirements.

The Masters of Education with licensure consists of 45 credits of coursework and one semester of student teaching.
